## *WELCOMING NOTE*

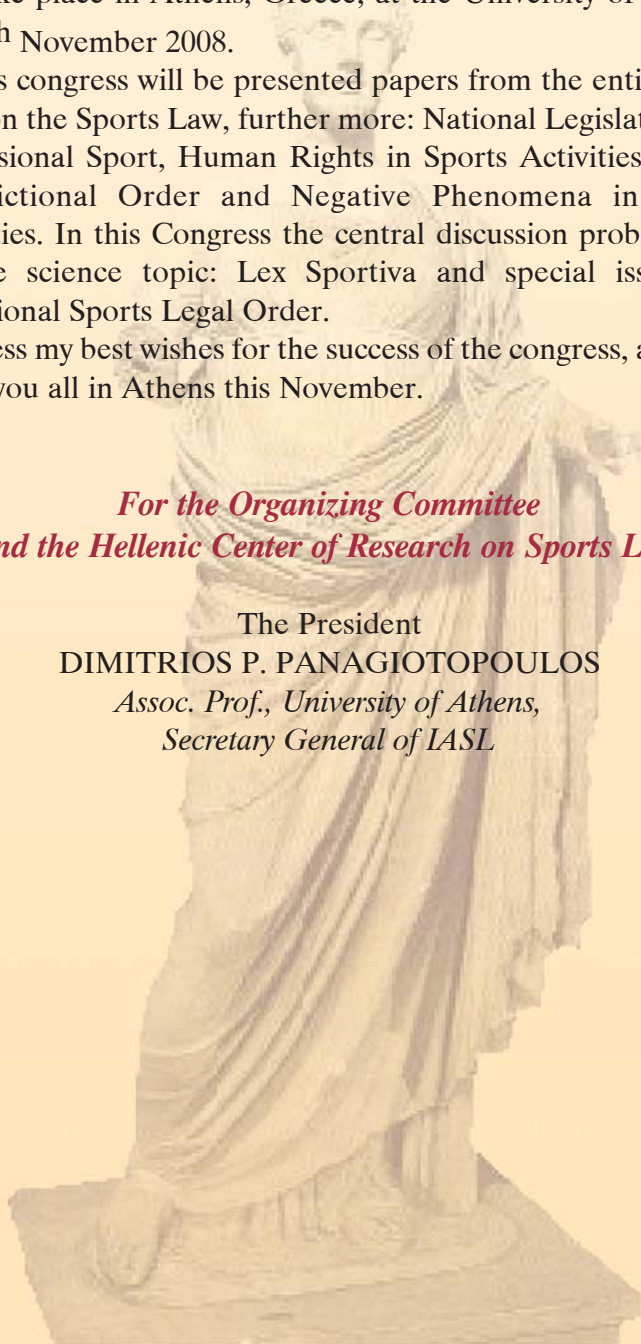

- The texts of the 14<sup>th</sup> World IASL Congress as well as the Findings of the Congress will be published by the H.C.R.S.L. (EKEAD) in a special edition (Proceedings) and some selected papers will be published in the *International Sports Law Review / Pandektis*.
