# 2010 International Symposium on the Revision of Sports Law

The Sports Law of the Republic of China (Referred as Sports Law) has been effective for 15 years since its announcement in 1995. With the development of Chinese society, some content of the Sports Law has not been able to meet the requirements of the development of Sports in a practical sense, and therefore is in need for revision. In recent years, some deputies of the National People's Congress, Political Consultative Conference, experts and professionals in law have also appealed to revise the Sports Law by means of proposals and suggestions, and conducted some theoretical research on the major content of the Sports Law, which resulted in some significant accomplishments.
