Report editing instructions:

Format: WORD file.

Maximum number of characters: up to 15 000, counting spaces, (9 pages A4).

Use Times New Roman font, size 14, at 1,5 line spacing. Indent – 1, 25 cm. Top margin 3 cm, left margin 3 cm, right margin 2 cm, bottom margin 2 cm.

Footnotes are typed per page using Times New Roman font, size 12, at one line spacing. Requirements for footnotes are also available in Russian Federation all-union state standard *P 7.0.5-2008 System of standards on information, librarianship and publishing. Bibliographic reference. General requirements and rules of making.* (ГОСТ P 7.0.5-2008)

The reports must contain annotation (summary) and key words. The theme of reports must be relevant to the theme of the Conference. Editorial board of the Conference has the right at its own discretion to decline, to shorten or to return to the author for the correction the reports mismatching the abovementioned requirements.
