10th KASEL International Conference -Summary

The Korean Association of Sports & Entertainment Law(KASEL) had held 10th International Conference at Jangan University in Korea from October 12(Fri.) to 15(Sun.), 2012. The theme of this international conference was "A New Trend of Sport Law – Legal Challenges to Promote School Sports and Physical Education & Ideas to Ensure the Fairness in the Sport Industry."

In October 13 when the main event was held, opening ceremony was started with the opening address delivered by Yeun, Kee-Young, President of KASEL and proceeded welcoming address by Do, Joong-Dae, president of Jangan University and congratulatory address by Dimitrios Panagiotopoulus, president of IASL.

After opening ceremony, keynote speech was followed by 6 prominent speakers from foreign countries. As a first keynote speaker, Dimitrios Panagiotopoulus, president of IASL, presented about "Prospects for EU Action in the Field of Sport after the Lisbon Treaty". Dr. Panagiotopoulus explained that since December 2009 when the Lisbon Treaty came into force, sport is mentioned for the first time in a European Treaty. The Union agreed to contribute to the promotion of European sporting issues.

As a second keynote speaker, Yeh, Kong-Ting, Dean, College of Management, National Taiwan Sport University, spoke "The Impact of 2012 Sport Industry Promotion Law on Taiwan." Dr. Yeh also emphasized on the effort and financial support by government to promote the sport industry.

As a third speaker, Klaus Vieweg, professor, Law School of Friedrich-Alexander University Erlangen-Nuremberg in Germany, presented about "Legal Problems of the Social Techno-Doping". Dr. Vieweg defined the Techno-Doping as all types of technical means which are related to unfair advantages, threat of players' health, and harm of sport

reputation. Many disables use various techno means to perform their sport skill but sometime these techno means may be problem for the federation or court in terms of equal opportunity. He concluded that which techno means could be accepted or rejected is remained as an issue to be solved.

Mr. Amaresh Kumar, Advocate, Supreme Court of India, explained that school sports and physical education are governed by each different government department. He also explained the difference between two systems, roles and legal issues.

Professor Andras Nemes, Physical Education & Sport Science Department, Semmelweis University in Hungary, spoke that sport manager should find and control the risk top-class athletes are exposed at their training field. As a last keynote speaker, Yeun, Kee-Young, president of KASEL, spoke *on "Legal-Institutional Tasks to Enact Subordinate Ordinance of School Sport Promotion Act"*.

At the second session of the main event, several prominent scholars presented and discussed ardently about the topic of "Legal Challenges to Promote School Sports and Physical Education" and "Ideas to Ensure the Fairness in the Sport Industry". It is evaluated that the various academic exchanges and sincere communications showed through this International Conference of KASEL contributed to the development of not only Korea but also International sport law.
